27 May 5pm	Application Closing Date Match closes for: <ul style="list-style-type: none"> • Candidate Applications to participate in match via PMCV Allocation & Placement System (APS) • Completion of CV form (online) • Referee nominations and referees' submission of reports • Adding new Health Service preferences (<i>candidates can reorder preferences until 20 July 2023</i>) • Updates to application details, CV and supporting information
28 May 10am	PMCV to provide list of approved trainees in match to VPTC <ul style="list-style-type: none"> • VPTC receive list of candidates approved to participate in the match allocation
28 May 10am	Video Interviews Open Candidates access link in APS to open, record, complete Video Interview Questions
30 May 5pm	Video Interviews Close Video Interview Questions must be completed by 5:00 PM

3 - 6 June	VPTC Shortlisting <ul style="list-style-type: none"> - Monday 3 June: PMCV send applicant data to VPTC - Thursday 6 June: VPTC initial meeting to review shortlisted candidates
13 June 9am	Health Services access shortlisted candidates Health Services can access shortlisted candidates' application information and referee reports (only those candidates that have listed the health service as a preference)
18 July	VPTC to provide PMCV with a list of successful candidates following the selection interview process. PMCV to withdraw candidates who have not been successful in the VPTC selection process to enter the Match.
22 July 5 pm	Closing date / match closes for Candidates to: <ul style="list-style-type: none"> • Withdraw from Match • Delete/Reorder preferences (existing preferences only)
Health Service Ranking	
22 July 5:01 pm – 26 July 11.59PM	Health Service Assessment / Ranking Period Health Services can view a list of candidates approved as eligible (shortlisted) for the Match, who have included that health service in their preference list (note: candidates' preference order is not disclosed to health services)

	Health Services submit online list of preferred trainees in rank order

30 July – 02 August	PMCV Conducts Match PMCV algorithm run to match candidates to Health Services and check results
Match Results	
08 August 10am	Match Results Published Match results are available to trainees and health service administrators (HODs/HOUs) via the PMCV Allocation and Placement Service website (login required).
11 August 10am	Accept/Decline Deadline Applicants that have been allocated a position must accept or decline their position via the Accept/Decline button. Failure to accept the allocated position by this deadline will result in an automatic decline.
13 August 10am	Post-Match Process Post-Match- sharing of unmatched candidates' details to health services for potential unaccredited training positions. (Candidates' approval required).
7 September 2024	Final date to apply for mid-year entry for successful applicants
