Paediatrics and Child and Adolescent Psychiatry 2017 Reciprocal Training Arrangements Guide

About this Guide

This guide has been developed by the Royal Australasian College of Physicians (RACP) and the Royal Australian & New Zealand College of Psychiatrists (RANZCP) to provide trainees and supervisors with advice on how to complete Advanced Physician Training in Community Child Health or Advanced Physician Training in General Paediatrics concurrently with training in Child and Adolescent Psychiatry.

The reciprocal training arrangements outlined in this guide offer medical graduates an opportunity to gain Fellowship of both colleges (FRACP and FRANZCP) in a reduced time period than that of the current duration required to gain Fellowships sequentially. The shortened overall time requirement for dual Fellowship is achieved by simultaneous recognition of supervised training in overlapping domains of the two curricula.

Over the course of the training programs, trainees must carry out a variety of teaching and learning activities, assessments and other program requirements in consultation with their supervisors. Satisfactory completion of the requirements set out in the relevant RACP and RANZCP Training Handbooks is a prerequisite for admission to Fellowship of the RACP and Fellowship of the RANZCP.

Each training program is governed separately by the respective College. Each College can make its own decisions about the progression of individual trainees (certification/accreditation of training); the award of Fellowship; and changes to training program requirements using existing processes and structures. Trainees must plan their training in order to comply with both College's policies and procedures

This guide applies to trainees registered in Australia or New Zealand in 2017. It includes information for both Australian and New Zealand based trainees and supervisors. Where not specified as being particular to either Australia or New Zealand, information applies to trainees and supervisors in both countries.

Program Overview

Trainees must complete all RACP requirements for Advanced Training in Community Child Health or Advanced Training in General Paediatrics, and all requirements of the RANZCP 2012 Fellowship Program and Certificate of Advanced Training in Child and Adolescent Psychiatry.

RACP Advanced Training in Community Child Health

Trainees undertaking the reciprocal training arrangement in Community Child Health and Child and Adolescent Psychiatry, would need to fulfil all the requirements of Advanced Training in Community Child Health set out in the 2017-18 Program Requirements Handbook.

Trainees undertaking the reciprocal training arrangements would need to fulfil all the requirements of the RANZCP 2012 Fellowship Program and Certificate of Advanced Training in Child and Adolescent Psychiatry.

Examples of Reciprocal Training Arrangements

The following diagrams are examples of what the reciprocal training arrangements may look like in practice for a trainee to complete Basic Physician Training and Advanced Training in Community Child Health or Advanced Training in General Paediatrics, concurrently with training in Child and Adolescent Psychiatry.

A trainee undertaking both RACP and RANZCP training as separate programs would spend a minimum of **11** years in training. However, a trainee who seeks dual recognition of appropriate training rotations and requirements by both colleges may be able to complete both training programs in a minimum of **8** years.

The examples shown in the tables below are intended to provide an indication of how training in the two programs may be structured for maximum efficiency by highlighting potential areas of overlap that could be counted towards completion of both programs.

The examples are not intended to imply restrictions around the chronological order of training terms, nor are they intended to be considered as the complete list of training experiences and requirements that trainees will need to undertake prior to completing both RACP and RANZCP training.

Assumptions

In developing the examples in the tables below the following assumptions have been made:

- The trainee is able to obtain the training rotations shown in the examples.
- All training is full-time and completed satisfactorily.
- The trainee passes every assessment on the first attempt.
- The trainee does not interrupt their training, i.e., take leave in excess of eight weeks.
- There are no exemptions from training time beyond what is indicated in the current training requirements.

Training Processes and Policies

Entering the program

Trainees must meet the entry requirements of the respective College prior to entry into the relevant program. Trainees must adhere to the registration process for each College.

When a trainee wishes to apply for simultaneous recognition for a training period by both Colleges, they must complete the relevant College forms and submit these separately to each College.

At the time of registration, Trainees who indicate that they wish to join the reciprocal training arrangements will be asked to provide their consent for their information to be shared between Colleges.

RACP

RACP trainees may commence Advanced Training in Community Child Health or Advanced Training in General Paediatrics following satisfactory completion of Basic Training requirements including success in the Divisional Written and Clinical Examinations, and appointment to an appropriate Advanced Training position.

Candidates must secure an Advanced Training position at a suitable training site. Core training usually needs to be undertaken at [training sites accredited by the RACP](#) for Advanced Training in Community Child Health or Advanced Training in General Paediatrics.

Once trainees have secured a training position, they must apply prospectively each year for the approval of their training in accordance with the due dates below. Annual Applications can be made [online](#). Trainees must organise the timely submission of all necessary documentation and keep a copy of the application for future reference.

Trainees must indicate on the annual application for approval of RACP Advanced Training that they wish to take part in the reciprocal training arrangements. Trainee details will be provided to the RANZCP who will then contact trainees about the RANZCP selection process.

For any periods of RANZCP training that will not be accepted by the RACP, Trainees will be required to submit an Application for Interruption of Training to the RACP indicating that they are completing a psychiatry rotation and pay the relevant fee.

The reciprocal training arrangements are not available to individuals who already hold FRACP. Individuals who hold FRACP wishing to train in Child and Adolescent Psychiatry should contact the RANZCP for advice about entry requirements and recognition of prior learning.

Closing dates for RACP applications in Australia

15 February	Closing date for applications for prospective approval of rotations in the current year
31 August	Closing date for applications for prospective approval of rotations in the second half of the current year

Closing dates for RACP applications in New Zealand

31 March	Closing date for applications for prospective approval of April - August rotations
31 May	Closing date for applications for prospective approval of rotations in the second half of the current year and August - December rotations
31 October	Closing date for applications for prospective approval of rotations in the first half or whole of the following year and December - April rotations

RANZCP

Trainees must complete 36 months of RACP Basic Physician Training and at least 18 months of Advanced Training before commencing training with RANZCP.

There is a limit of 5 years break in training in between the two training programs. However, break in training while training at either College would be subject to the regulations of the College offering training.

Trainees are required to pass the RACP Research Project before entering training with RANZCP. Completion of this would gain exemption from the RANZCP Scholarly Project.

Trainees are ineligible to request recognition of prior learning within the RANZCP training program for any undertaking as a component of their RACP training.

Trainees are required to undertake training as per the developed learning streams. Trainees are unable to move between RACP and RANZCP training programs or undertake training out of sequence.

Candidates would need to secure an accredited Stage 2 training post before contacting the appropriate Branch Training Committee for selection process and interview with the Director Of Training and Director Of Advanced Training of Child and Adolescent Psychiatry. However, being selected in the training program, does not guarantee allocation of training posts in Advanced Training.

As RACP Advanced Training is accepted by the RANZCP, trainees are required to pay the RANZCP Administrative fee from the start of their RACP Advanced Training, regardless of their enrolment date in the Dual Fellowship Training Program (DFTP) Reciprocal Training Arrangements. The administrative fee of the enrolment date in the DFTP would apply to previous RACP Advanced Training prior to the entry of DFTP.

Trainees must complete all Stage 2 training requirements and pass the Multiple Choice Questions (MCQ) Exam before commencing training in Certificate of Advanced Training Child and Adolescent Psychiatry.

A trainee's progress along the Trainee Progress Trajectory will be adjusted to reflect the exemption of 18 months FTE RANZCP Training as a result of a successful DFTP application. A DFTP trainee will be considered to have completed 18 months FTE in relation to the Progression through Training Policy deadlines and will also be considered to have undertaken 18 calendar months training in relation to the Failure to Progress Policy maximum training time requirements.

Trainees are ineligible to enrol in Dual Certificate Advanced Training with RANZCP.

Trainees who have exited the DFTP within 8 years could re-enter the DFTP. Trainees wishing to re-join the DFTP after 8 years would need to refresh their training experiences as per regulations of the Colleges before training can be recommenced. Trainees are required to pay the re-entry fee at each College as well as the appropriate training fees. Trainees need to settle all fee arrears before re-entry would be considered.

Closing dates for RANZCP Applications

Approval and Certification of Training

Each training program is governed separately by the respective College. Each College can make its own decisions about the progression of individual trainees (Approval and Certification of training).

RACP

Approval of training periods will be determined by the relevant overseeing committee; Advanced Training Committee in Community Child Health or Advanced Training Committee in General Paediatrics. To be approved, a trainee's individual training program must be consistent with the training requirements and appropriate for the stage in training.

Upon completion of each rotation or calendar year of training, the overseeing committee considers each trainee's progress according to requirements. If all requirements of training have been satisfactorily completed, the overseeing committee will certify the period of training and advise the

trainee in writing of the decision. For more information about approval and certification of training, please refer to the [Progression through Training policy](#).

RANZCP

The Committee for Training oversees all training at RANZCP. A subcommittee for Certificate of Advanced Training in Child and Adolescent oversees trainees undertaking the Certificate of Advanced Training in Child and Adolescent.

Trainees are required to comply with the [RANZCP Regulations, policies and procedures](#) when training with RANZCP.

Local support from a Director of Training or a Director of Advanced Training is available during each rotation.

Training fees

If a proposed training period is accepted by both Colleges' concurrently, the trainee will be required to pay the relevant annual training fee to each College. If a training period is not accepted by one of the Colleges, the trainee will not be required to pay the relevant annual training fee to that College but may be required to pay an administrative fee (i.e. RACP Application for Interruption fee or RANZCP Administration fee).

Admission to Fellowship

Trainees are eligible to be admitted to Fellowship of the RACP and Fellowship of the RANZCP on the completion of all relevant requirements of each training program. Trainees will be notified by the relevant College once the overseeing committee has recommended them for admission to Fellowship, to invite them to apply for admission to Fellowship. The admission process involves completion of an application form, and the payment of a fee prior to admission.

Fellowship can be awarded for completion of one training program independently of progress in the other training program. FRACP in Community Child Health or FRACP in General Paediatrics can be awarded before completion of psychiatry training.

Trainees withdrawing from either program will need to meet the full requirements of the respective College training program in order to be eligible for Fellowship.
