## Election Processes for Bi-national Faculty Committees

This Supplementary Fact Sheet relates only to Bi-national Faculty Committees for positions which are subject to election processes in 2022. It details the election processes taking into account the various appointment scenarios detailed in the <u>Bi-national Faculty Committees' Regulations</u>. The content is in addition to the <u>Fact Sheet</u> relating to RANZCP Committee Elections 2022.

Position and Appointment Scenario	<b>Election Process</b> The minimum membership requirement for the Bi-national Faculty Committee to function is 50% of the Committee's total voting membership.	
Chair (Must be a Fellow and an Accredited Member of the Faculty)		
Not currently in a final term	Reappointment will be offered in line with the <u>Fact Sheet</u> . If a call for nominations is required, it will be open for a 2 week period (if an extension is required this will be limited to an additional 2 week period).	
Currently in a final term	A call for nominations for the position will first take place. The call for nominations will be open for a 2 week period (if an extension is required this will be limited to an additional 2 week period). If the position is filled following the call for nominations, at the discretion of the incoming committee Chair, the current Chair may be offered the option of remaining on the committee in a Past Chair co-opted position for 12 months. If no nominations are received, the current Chair may then be offered reappointment (providing that the individual has not been on the committee in a voting position for 12 or more years consecutively).	
Holding a Casual Vacancy/Vacancy	Reappointment will be offered for a term of 3 years.

Any current vacant positions	A call for nominations for each vacant position(s) will first take place. Calls for nominations will only be open for a 2 week period (no extensions). If the position is not filled following a call for nominations, the position may be offered to those currently holding a Jurisdictional Member position where they do not reside in that jurisdiction (if they have not yet secured a committee Jurisdictional Member position). If still not filled, the position will remain vacant.	
Jurisdictional Member who is currently the Chair of the Faculty Subcommittee		
Not currently in a final Term <i>OR</i> Holding a Casual Vacancy/Vacancy	Once the Faculty Subcommittee is formed, the Subcommittee will be asked to reappoint its Chair. This individual will then hold the respective jurisdictional position on the Bi-national Faculty Committee.	
Currently in a final term	Once the Subcommittee is formed, the Subcommittee will be asked to appoint a Chair from among its Members who are a Fellow or Affiliate and an Accredited Member of the Faculty. This individual will then hold the respective jurisdictional position on the Bi-national Faculty Committee.

Chair Subcommittee for Advanced Training (SAT) (relevant to Faculty) or their nominee within that SAT	Election processes will take place in accordance with SAT Regulations.
Co-opted Members	Current Co-opted Members may apply for a position (where eligible) if a call for nominations is taking place.
	At the end of the election processes the Committee (once formed) may, at is discretion, reconfirm the Co-opted Member appointment.
