Forensic Trainee Sponsorship Terms and Conditions

Applying for a Forensic Trainee Sponsorship to attend the **Royal Australian and New Zealand College of Psychiatrists (RANZCP)** <u>2025 Faculty of Forensic Psychiatry Conference</u>, constitutes acceptance of all terms and conditions below.

Sponsorship details

Twenty (20) sponsorship places are on offer for Forensic Trainees to attend the <u>2025 Faculty of Forensic Psychiatry Conference</u>, being held at Novotel on Collins, Melbourne, VIC from Wednesday 13 August to Saturday 16 August 2025.

Eligible applicants must be a current RANZCP Forensic trainee from Australia or New Zealand. Trainees who are trainees or Fellows of another specialty are ineligible to apply.

The sponsorship is valued at approximately A\$400-\$1000 and comprises:

- Full conference registration including welcome reception.
- Free Registration for 'Report writing a workshop for Forensic trainees' Saturday morning (8:15-10:30am) - with Dr Calum Smith, Prof Andy Carroll, A/Prof Andrew Ellis, Dr Kerri Eagle, Dr Sarah Dorrington and Tim Marsh
- Travel support*, including flights or road travel costs, as well as accommodation for eligible Forensic trainees:
 - Reimbursement of up to \$400 for VIC-based Forensic trainees, within 200km radius of the conference location.
 - Reimbursement of up to \$1000 for Forensic trainees outside of VIC (200km+ radius from the conference location).

*The travel grant will be reimbursed post conference attendance, upon the provision of supporting receipts/tax invoices.

Sponsorship recipients <u>must</u> attend the full program from Wednesday 13 August to Saturday 16 August 2025, including workshop on Saturday morning (8:15-10:30am) - 'Report writing – a workshop for Forensic trainees' with Dr Calum Smith, Prof Andy Carroll, A/Prof Andrew Ellis, Dr Kerri Eagle, Dr Sarah Dorrington and Tim Marsh.

Meals outside of the conference program are not included in this sponsorship.

Applications must be submitted electronically via the <u>online application form</u> by Friday 6 June 2025. Applications received after this time will not be accepted.

The Selection Panel will select the successful applicants on a first come first serve basis. The Selection Panel's decision is final.

The outcome will be announced in mid/ end June and successful applicants are required to confirm their acceptance of a sponsorship by email by the deadline provided.

Evaluation

Sponsorship recipients will be required to submit a short reflection on their attendance at the event.
