Position Description

Accreditation Officer, Accreditation Assessment Panels: Fellowship Programs and Zones





Responsibilities/Role:

- Participate in Fellowship Program accreditation assessments.
- Liaise with panel members during the accreditation assessments.
- Contribute to the development of pre-assessment documentation and facilitate the accreditation assessment panel's familiarity with documentation. This includes Medical Training Survey (MTS) data.
- Liaise with local administration to prepare the timetable and ensure local arrangements are in place.
- Ensure all local stakeholders are abreast of the accreditation activity as suitable.
- Coordinate and participate in the pre-assessment panel meeting and on-site meetings.
- Determine, with the Assessment Panel, the recommendation regarding ongoing accreditation of the Fellowship Program and the commendations and recommendations of the assessment.
- Record (minute) the assessment in order to produce the draft Accreditation Assessment Report.
- Participate in meeting with the local Director of Training (DOT) and Assessment Panel at the conclusion of an assessment for informal debriefing.
- Ensure meeting attendees understand how their feedback will be used.
- Ensure any significant concerns are addressed as required by the <u>Accreditation Policy</u> and the Removal of Accreditation Policy, and that the panel is aware of such requirements.
- Complete the draft accreditation assessment report, finalise the draft with the Panel, and participate in post-assessment meetings.
- Submit the Accreditation Report for approval as required by the Accreditation Standard Operating Procedures and circulate as required.
- Contribute to and coordinate the improvement of the Fellowship Program accreditation processes and procedures.

Selection Criteria:

- Appointment as a RANZCP Education and Training staff member with appropriate accreditation assessment training.
- A commitment to the administrative support of psychiatry training.

Voting Rights:

A full voting member of the Panel.
